1. Welcome

Chair Meyer called the meeting to order on October 5, 2023 with all members present.

2. and 3. Roll Call, Confirmation and Verification

Kristen Dwyer called roll, confirmed posting and verified quorum.

5. Discussion/Informational Only – NPWR Updates

Chair Meyer and Kristen Dwyer welcomed new member Toni Giddens from the Department of Business and Industry who is bringing apprenticeship data to NPWR. Also welcomed Molly Lennon from the Department of Motor Vehicles. There has also been an update on the NPWR representative from DETR to now being Krista Marshall. And acknowledgement of the newer partners Christopher Franklin from the Department of Corrections, Brandon Torres from Department of Veteran Services, and Kristen Dwyer as the Committee representative from the Governor's Office of Workforce Innovation.

Kristen Dwyer also shared that onboarding Title I and Title III data into the system, with the help of Krista Marshall, and working to onboard NDOC, NDVS and B&I in the coming months.

Kristen Dwyer will be sending out proposed calendar invites for the 2024 quarterly meetings.

6. Discussion/Informational Only – Partner Activities Updates

Chair Meyer shared that NDE was awarded the SLDS grant that will work to enhance the NPWR system, and is working with UNLV on this initiative, with the entity being one of the research grant recipients from the spring.

Nancy Olsen shared that completed federal statistical report for adult education and all the impact performances were met.

7. Discussion/Informational Only – GOWINN Updates

Kristen Dwyer shared the office is currently without an Executive Director, provided an update on

the Data Labs initiative, which includes an update coming around the data sharing agreement and the first Strategic Plan that will be shared with the Committee in the following month. Also shared the upcoming events in December – of the two NPWR Research Forums on 12/5 at UNR and 12/7 at UNLV, along with a presentation to the Governor's Workforce Development Board on 12/13. Kristen also invited the first recipients of the NPWR Research Grants to the meeting today, as received feedback from the researchers around the NPWR portal and system and shared with the Committee. The feedback was often around how to make it easier to process through the asks. From the success and feedback of the inaugural NPWR Research Grants, the office received an additional \$230,000 to fund projects for the current fiscal year, with the application being released later in the month. Also, as shared in the last meeting and due to feedback from the researchers and the data partners, working to enhance the NPWR portal system to making the approval process easier and into more of a one-time approval.

8. Discussion/Informational Only – Program Activities Updates

Craig Moebus from DBDriven shared updates around the NPWR system, with the main aspects being helping to create updates on the information in the Data Dictionary to help researchers and that DBDriven is working through the new IMR implementation and has reached out to organizations that questions arose on.
